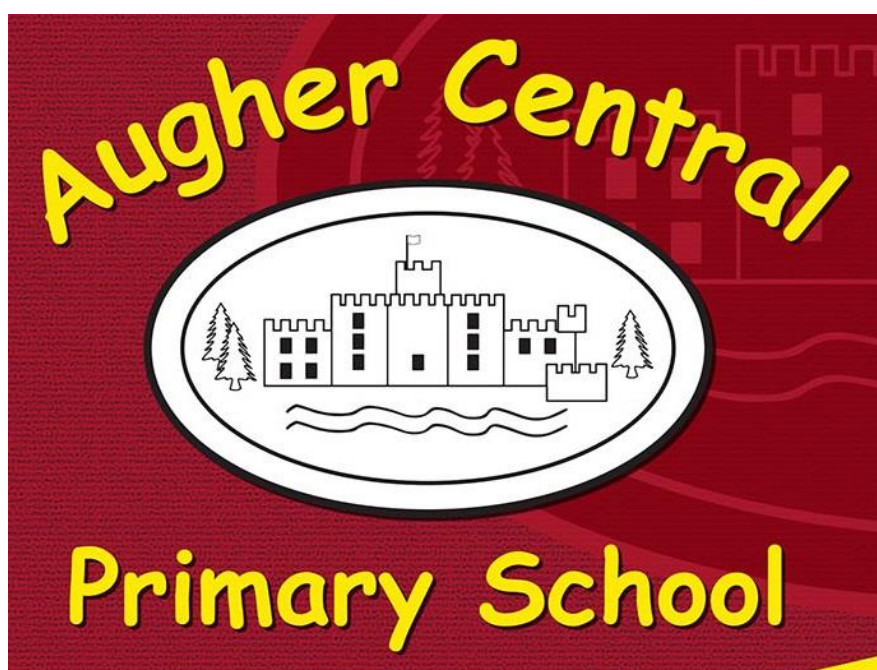

School Uniform Policy

Introduction

It is our school policy that all children wear school uniform when attending school or when participating in a school organised event outside of normal school hours.

Aims and objectives

Our policy for school uniform is based on the notion that school uniform:

- promotes a sense of pride in the school;
- engenders a sense of community and belonging towards the school;
- is practical and smart;
- makes children feel equal to their peers in terms of appearance;
- is regarded as suitable wear for school and is considered by parents as good value for money;
- is designed with health and safety in mind.

School Uniform Requirement

Pupils have PE two days per week, and on occasion some other days when linked to Sports activities. If pupils are staying for after school clubs they must change into their PE kits after school.

PE kit can be purchased as a special pack which includes a swimming or shoe bag, items can also be purchased individually.

(If children do not have plain black bottoms, they may wear their school uniform and change into PE kit)

Pupils will be encouraged by staff to wear the correct uniforms and to be organised in relation to PE days and full uniform days.

Jewellery

The wearing of jewellery is not allowed, as it can be dangerous both to the wearer and others. Older children may also wear watches. Children will be asked to remove watches for swimming and PE. Ear rings are not permitted due to Health and Safety recommendations, studs may be permitted if accompanied by a written note from parents – these should be removed for PE or covered with Micro tape.

Hair

All children, girls and boys, are requested to have their hair tied back when it is long enough to do so. This is both for smartness and health and safety reasons. All long hair must be tied back for PE and cookery. Boys' hair should be cut in a neat fashion and no scalp should be evident. (No number 1) Children are discouraged from colouring their hair.

The role of parents/carers

We ask all parents and carers who send their children to our school to support the school uniform policy. It is the responsibility of parents and carers to ensure that their child has the correct uniform and that it is clean, in good repair and named. Parents sign up and agree to this policy when their child joins Augher CPS and are responsible for working with school to ensure the uniform policy is implemented.

The role of the Principal

The Principal:

- is responsible for ensuring compliance with this uniform policy;
- may grant special dispensation on the basis of a temporary medical need; and
- will be available for parents to consult with on any issues;
- will speak to parents about any areas of the uniform policy which may arise

The role of the Board of Governors

The governing body is responsible for deciding the requirements for school uniform and other rules relating to appearance. This policy will be monitored and reviewed on a three-year cycle.

All parents will receive this policy when children commence school and are expected to comply with the policy
